## **UPDATE\*** Walk in Policy

From the 1st November 2021 there will be an out-of-pocket expense for all walk-in patients. <u>This is during the WEEKENDS and PUBLIC HOLIDAYS only.</u>

Medicare rebates will vary depending on the time of consultation (in hours or after hours). The minimum gap will be \$30.00. The rebate will be reflected into your nominated bank account generally within 24-48 hours.

The fees that are generated from patient appointments have to cover the expenses of running a medical centre. This includes administration costs, cleaning staff, building lease, electricity, phones, water, computer and software fees, and so on and so forth. As the gap between rebate increases and cost increase widens, it has become more difficult to maintain a viable business by bulk billing all patients. There is also a shortage on doctors currently and they are in high demand.

At our practice, our aim is to provide consistent, high-quality and personalised care that puts our patients first, making them feel like they are not a number, that they are supported and respected so we need to spend dedicated time for investigations, discussions and follow up plans.

## \*UPDATE - Telephone Appointments

Due to recent review of Telehealth services by Medicare Australia, telephone consultations will no longer be bulk billed. **This is effective from Monday 12 July 2021.** A private fee will apply and payment will be collected prior to the consultation, via a payment request we send from Hot Doc, or over the phone. Medicare rebates will be processed online to save you hassle and be reflected into your nominated bank account within 24 hours.

Please note, if you have not been seen by a GP at our practice face-to-face in the last 12 months, Medicare will no longer provide a rebate for Medicare Telephone services. You will be required to pay the full amount.
